# Our charges

We would, however, expect such fees to be within the following ranges in relation to the different immigration categories. Please also note that the fees set out below <u>are per applicant</u>.

All figures **exclude** VAT unless specifically stated. The agreed fee will depend on the complexity of the matter and the casework involved such as, the amount of supporting evidence that we need to consider, which language(s) you speak, whether you are applying with other dependants and whether or not this is an initial application, extension or an Indefinite leave to remain application.

All applications are likely to vary and of course, we can give you a more accurate estimate once we have more information about your specific case.

### What services are included with the fee?

### Our service includes:

- discussing your circumstances in detail and confirming whether this is the most appropriate application for you to make and what other options may be available to you;
- giving you advice about the requirements of the Immigration Rules and whether you meet the criteria.
- if you do not fulfil certain criteria, whether this can be overcome and how;
- considering the supporting evidence, you have provided;
- where necessary, helping you obtain further evidence (such as medical records and bank statements), including taking statements of any witnesses;
- preparing your application and submitting it on your behalf;



- Attendance at a Home Office interview: if the Home Office ask you to attend an interview, we
  will give you clear advice (and discuss the possibility of us attending with you) at the
  appropriate time.
- Giving you advice about the outcome of the application and any further steps you need to take.

#### What is not included within the fee?

Disbursements are costs related to your matter that are payable to third parties, such as visa fees. We handle the payment of the disbursements on your behalf to ensure a smoother process but these are separate from our fees:

- Interpreters' fees. Not all cases will require the services of an interpreter and in some situations, clients will bring a friend or another community figure to come and help interpret.
   If the services of a professional interpreter are required, we will of course try to let you know as soon as possible and provide an indication of those costs.
- Translation fees. Immigration applications will usually include documents that are not in English and if we are relying on these for a particular application or appeal the Home Office or the tribunal will require these to be translated.
- Barristers' fees. In some cases, we may require the advice or assistance of a barrister either in relation to your application or appeal. We will of course let you know as soon as possible if this is required and we will try to give you several options for you to consider.
- Other professional service providers such as business plan writers, accountants, property surveyors.
- Independent expert reports e.g., medical experts. These are not required in many cases. We will let you know as soon as possible if we consider an expert report is necessary.
- If there is a Home Office interview and we do attend with you, there will be additional disbursements in respect of our mileage/travel expenses.

The costs quoted here do not include:

- Any <u>Home Office fees</u> for making the application. You will pay this to the Home Office directly as part of the application process.
- Where the Home Office refuse your application, advice and assistance in relation to any appeal or administrative review.

# How long will my application take?

We cannot guarantee how long the Home Office will take to process your application. Read the current Home Office processing times.

Please note that for some applications the Home Office do offer faster track services (at extra cost) which means your application can be decided quicker than the usual published timescales.

Once we have more information from you, we can advise you as to whether or not you can use these services.
